1. "We believe the City must increase its options for solutions to the housing squeeze"

## Calgary Transportation Plan (GoPlan) and its principles of balance growth strategy?"

The Go Plan is an excellent plan that needs to be revisited to meet with today's needs.

Communities need to have walk-able access to things that they need. After that, they need access to transit so that they may become less reliant on using cars as their primary source of mobility.

It is important that we plan Transit-oriented development and create larger parking spaces for C-Train stations. Like the European model, people who drive to the station are able to shop, attend their kids' activities and run errands on the way home from the station at the end of the day, thereby, putting their spending dollars in their local communities and making their day a whole lot more convenient.

Thinking about the travel patterns of commuters is important part of making the Go Plan become viable.

The new West bound C-Train should consider going to Mount Royal College. There will be a lot of commercial and residential areas for the C-train to service there as well as the College whose population alone would benefit greatly from C-Train service.

3. "We believe the current system is unfair to a wide range of Calgarians and has negative planning implications for the city as a whole."
